I acknowledge a.) the propensity of the animal to behave in ways that may result in injury, harm or death to persons on or around these large powerful potentially dangerous animals can behave, b.) the unpredictability of the animals reactions to sudden movements, sounds and unfamiliar objects persons or other animals, c.) certain hazards such as surface or subsurface conditions, d.) collisions with objects or other animals, e.) the potential of myself or others to act in a negligent manner that may contribute to injury to myself or others, f.) other unforeseeable events or accidents associated with being around horses in any way. **Initial** _____

I understand that the provisions of the Arizona Equine Liability Statute, ARS 12-553, are applicable to this waiver and I am aware and understand the inherent risks associated with equine activities and I am willing to accept full responsibility for my own safety and welfare; thus I release Blue Moon Rescue and Sanctuary, the property owners, David and Candy Rotering and all board members from any and all liability associated with any activity on this property. **Initial** _____
